2. 20 Edgerton Drive, 9 units – 20-year contract -vote

Linda Clark appeared representing Falmouth Housing Corporation. Bobbi Richards explained that over the years there have been errors on the part of FHA regarding extensions of contracts. For 20 Edgerton Drive, an outside entity was hired to manage the RFP for this property.

Therefore, there are no procurement issues. Bobbi Richards asked the board to approve the 20-year contract for 20 Edgerton Drive.

Bobbi Richards informed that the Gerald Flynn House, owned and operated by the Falmouth Housing Trust is in transition. The Trust is no longer interested in operating SROs and will seek to end the SRO, likely a two-year process. A subsidy is attached to the rooms.
