OPEN SESSION

At 4:35 p.m. Stephen Patton called the meeting to order and read regulations regarding remote meetings.

Bobbi Richards explained that Joseph Saint Germain and Ron Jean from Delta Wye oversaw the electrification project at Rose Morin which included replacement of the Federal Pacific panels.

Joseph Saint Germain reported that walkthroughs were done on 2 units on each of the 10 buildings after work was completed and good workmanship was found. The town has signed off on the project and Joseph Saint Germain will provide a copy of the approval to the housing authority for its records.

Kathleen Haynes moved to approve payment to Laracy Electrical for \$142,946, which represents both payment number one and substantial completion, along with costs for permits totaling \$6,282.39 for a final total of \$149,228.39. Patricia Favulli seconded.

Bobbi Richards said that she appreciated the work of Delta Wye on this project.

A question arose about the retainage. The board agreed that final payment would be approved at at a later meeting date.

-Harborview Ventilation – Designer Firm, Rogue Engineering – vote

Bobbi Richards explained that the ventilation issue has been an ongoing concern for the Town of Falmouth. It was determined that FHA disconnected the system years prior to the ED's hire and there was question regarding ventilation flow in the building. Bobbi Richards conducted an air quality study to determine that the levels were acceptable; the information was shared with the Town of Falmouth. Two studies of the system have been conducted; the project was put out to bid for a designer firm to draft the scope and manage the bid and construction process. Bobbi Richars has determined that there is funding available in the five year plan to address this concern. Rogue Engineering was the low bidder on the proposal and Bobbi Richards asked that they be awarded the project.

Ryan Nordstrom of Rogue Engineering was present. He noted that the firm had extensive experience with housing authorities across all classes of trade. He introduced team members Luis Olivia and Lucas Pomerleau. They reviewed the project explaining that the centralized option was the more cost effective. The system would have both heating and cooling components. Kitchen exhaust is not required by code and kitchen odors could be dealt with using the new ventilation system. The project will be invasive with tenants needing to be out of their units for several days as work was done.

Bobbi Richards explained that planning is underway for temporary housing for tenants and explained that relocation was previously added as a project to the five-year plan. FHA will be able to move funding under this allocation to meet the housing needs of the tenants during this planned work. As always, meetings will be held with tenants to determine their needs. During past projects, the Admiralty Hotel was a good resource and its rates tended to be lower than businesses nearby.

Michael Galasso wanted to see a schedule and to be sure that there were errors and omissions and liability insurance was in place for this very difficult technical project.

Ryan Nordstrom noted that on page 3 of the proposal the firm thought it could adhere to the timeframe outlined in the RFP. They can update the schedule to provide explicit dates.
